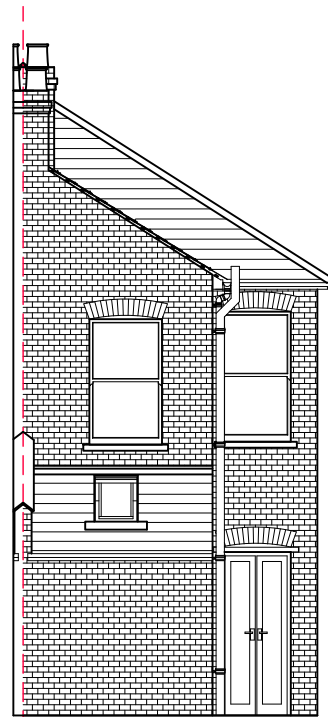

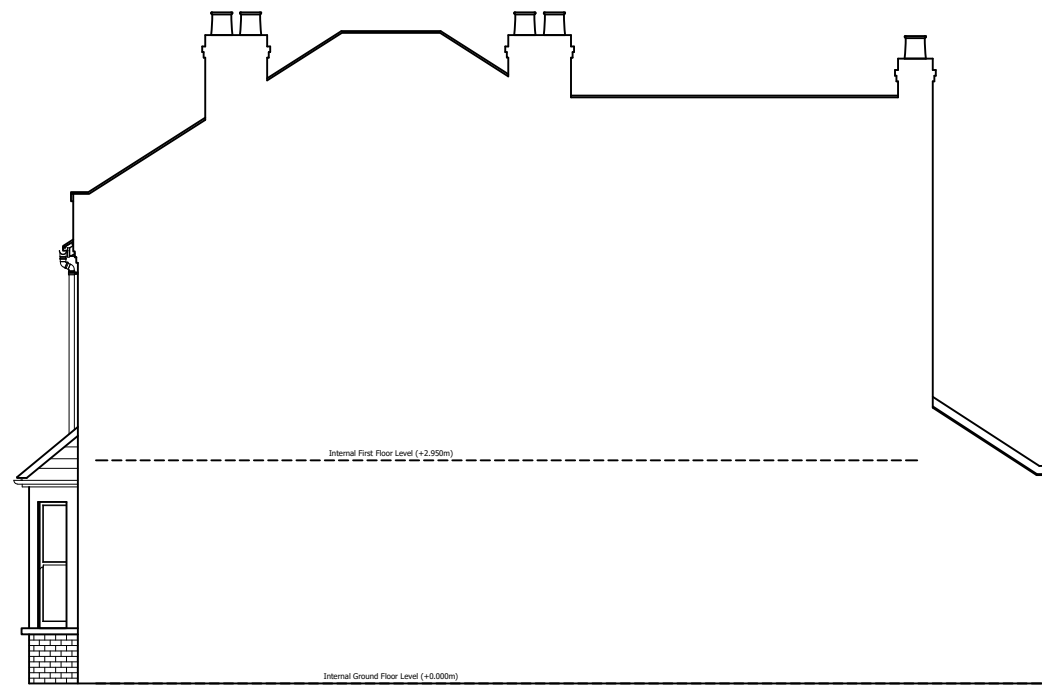
EXISTING FRONT ELEVATION

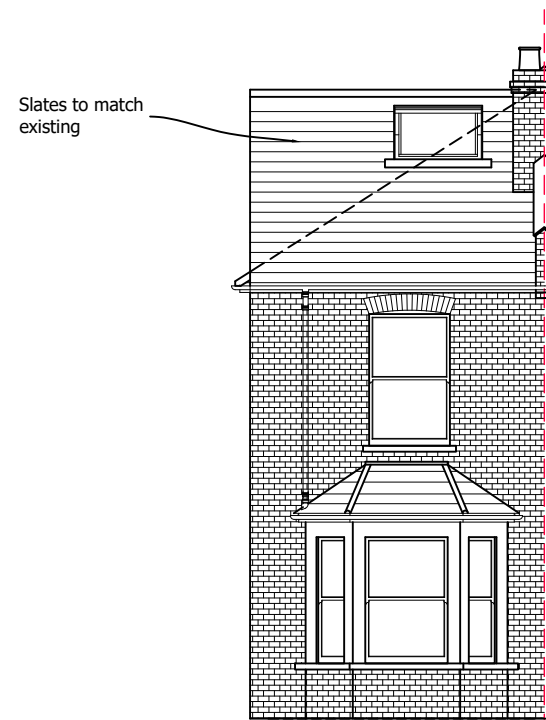

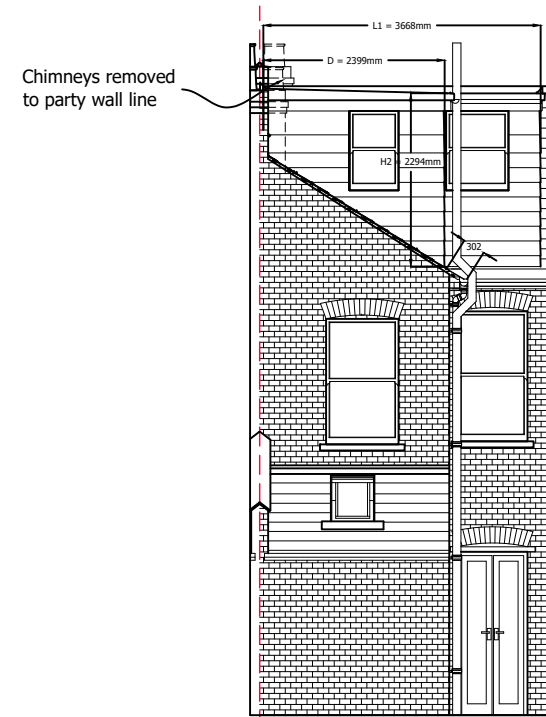

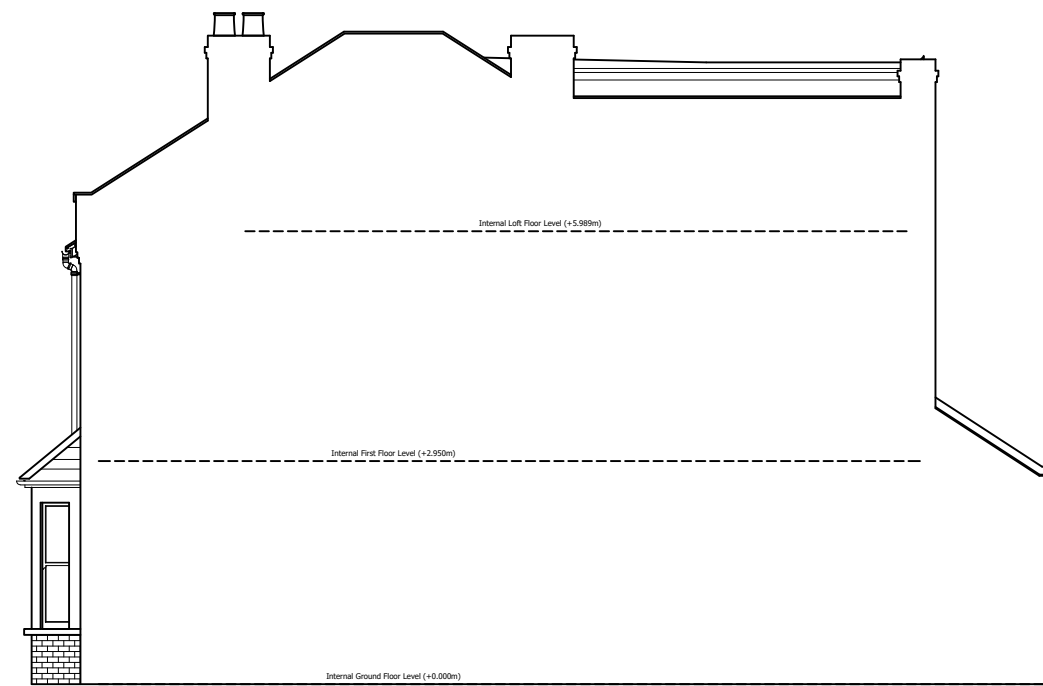
PROPOSED FRONT ELEVATION



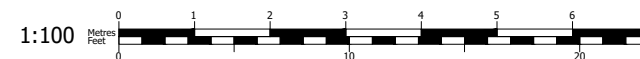
PROPOSED LEFT SIDE ELEVATION
